Ohio Limited Liability Company: Forms and Practice Manual, Harry L. Henning, Richard C. McQuown, with 2007 update and CDROM. Contains chapters on "Formation and Organization," "Capital Provisions," "Transfer and Buy-Sell Provisions," "Reorganization of the LLC," "Interstate Business," and "Compensation Strategies for the LLC." Selecting the Form of Business Entity: Analyzing LLCs and Other Choices, by Bruce D. Bernard and Thomas J. Sigmund, 2003. Focuses on the choice of entity for closely held companies. **KFO CLE/03-202**

An Estate Planner's Guide to Family Business Entities: Family Limited Partnerships, Limited Liability Companies and More, by Louis A. Mezzullo, 2003. Outlines the goals of estate planning, the tax and nontax benefits of limited partnerships and LLCs, compares entities, then discusses how to choose and form an entity. **KF1380 .C37 2003**

Individual chapters cover the subjects of tax classification, choice of business entity, comparison of entities, how to create an entity, the liability shield, governance, entity dissolution, and fiduciary duty. **KF1380 .Z9 B55**

Piercing the Corporate Veil, by Stephen B. Presser, 2007. Discusses the evolution of limited liability, "piercing the veil" of limited liability companies (in which individuals or corporate shareholders are exposed to personal or corporate liability), and state, federal and international laws related to "piercing the veil." **KF1423 .Z9 P74**
